1.2.1 There will be no briefing session for this Request for Proposal.

The bid number should be mentioned in all correspondence. Telephonic requests for clarification will not be accepted. If clarifying information will be made available to all bidders by e-mail only.

1.5 LATE BIDS

- 1.5.1 Bids received late shall not be considered. A bid will be considered late if it arrived only one second after 11h00 or any time thereafter. Bids arriving late will not be considered under any circumstances. Bids received late shall be returned unopened to the bidder with the person delivering the documents. Bidders are therefore strongly advised to ensure that bids be despatched allowing enough time for any unforeseen events that may delay the delivery of the bid.
- 1.5.2 The official Telkom time (dial 1026) will be used to verify the exact closing time (11h00)

1.5.3 Bids sent to SASSETA via normal post or any other mechanism shall be deemed to be received at the date and time of arrival at the SASSETA premises (tender/bid box or reception). Bids received at the physical address after the closing date and time of the bid, shall therefore be deemed to be received late.

The value of this bid is estimated <u>not to exceed</u> R50 000 000 (all applicable taxes included) and therefore the 80/20 system shall be applicable

Provide a work plan of activities. Part 11: Experience in this field

It is essential the service provider displays:

- ❖ The Bidder must provide signed reference letters on company letterheads of previous clients where the Bidder provided similar services.

Part 12: Bidders National Treasury CSD registration report

Bidders to submit their CSD report indicating the validity of the bidder's registration. Directors listed on SBD 4 to be the same as those listed on the CSD report.

1.8 NEGOTIATION

1.8.1 SASSETA has the right to enter into negotiation with a prospective service provider regarding any terms and conditions, including price(s), of a proposed contract.

- 1.8.2 SASSETA shall not be obliged to accept the lowest of any quotation, offer or bid.
- 1.8.3 SASSETA issues this bid invitation in good faith; however, it reserves the right to:
 - ❖ Cancel or delay the selection process at any time, without explanation,
 - Not to select any of the respondents to this bid invitation, without explanation,
 - Exclude certain services, without explanation.
- 1.8.4 All bidders will be informed whether they have been successful or not. A contract will only be deemed to be concluded when reduced to writing in a contract form signed by the designated responsible person of both parties.

1.9 REASONS FOR REJECTION

- 1.9.1 SASSETA shall reject a bid for the award of a contract if the recommended bidder has committed a proven corrupt or fraudulent act in competing for the particular contract.
- 1.9.2 SASSETA may disregard the bid of any bidder if that bidder, or any of its directors:
 - 1.9.2.1 have abused the Supply Chain Management systems of SASSETA.
 - 1.9.2.2 have committed proven fraud or any other improper conduct in relation to such systems.
 - 1.9.2.3 have failed to perform on any previous contract and the proof exists.
- 1.9.3 Such actions shall be communicated to the National Treasury.

2. TERMS OF REFERENCE

2.1 INTRODUCTION AND BACKGROUND

- 2.1.1 Safety and Security Sector Education and Training Authority (SASSETA) is an education and training authority established as a juristic person in terms Section 9 of Skills Development Act, 1998 (Act No. 97 of 1998 as amended).
- **2.1.2** The SETA lifespan is determined from time to time by the Minister of Higher Education and Training and SASSETA has been licensed until 31 March 2030.
- 2.1.3 SASSETA utilises Information and Communication Technology as the platform to manage and provide access its systems and communicate with its stakeholders. These include the internet/data and telecommunication services (in a form of telephone services). Currently the above services are provided by Liquid Telecom SA.

2.2 PURPOSE

The purpose of this RFP is to appoint a suitably qualified and licensed service provider (Telco and ISP) to provide the internet and telecommunication (telephone/voice) services to SASSETA for a period of 3 years from the date of appointment.

2.3 DETAILED SCOPE OF WORK AND DELIVERABLES

- **2.3.1** The scope of work will cover the following areas:
 - The ISP will provide full Transmission Control Protocol with Internet Protocol (TCP/IP) Internet Service Provision and telephone service for the SASSETA offices in Midrand. The service is expected to be highly accessible and reliable, with overall uptime of no less than 99%.
 - Internet (Data) and Telecommunication services to be provided on a subscription and per user basis.
 - The bidder shall provide the necessary hardware and other services required to setup the Internet connection and telephone service. It involves the following:
 - A dedicated, leased line of a minimum bandwidth of 300 Mbps Internet breakout from bidder's network, complete with relevant backup. This connection will primarily be used for internet browsing, hosted VoIP
 - The only option acceptable at the Head Office is Fibre optic; except for connection in the provinces.
 - For redundant connection, the bidder should provide a separate connection to different international gateway than primary connection through fiber optic connection.
 - No limitations on traffic/ports; bandwidth capacity should be ensured through direct IP connection; no mandatory proxy servers and firewalls.
 - The provided bandwidth must be dedicated (CIR 1:1).

- Internet service should not have additional payment or limitation by (a) traffic amount or (b) time.
- Service reliability must be ensured. Overall uptime should not be less than 99%.
- Data confidentiality guarantee; Provider may not scan traffic (if this should be done for finding problems in the network a prior UNDP agreement must be obtained).
- All necessary hardware, cabling and software (if required for Internet service) should be provided and set up cost should be included in the offer.
- Redundant, dedicated point to point links to the Internet.
- No firewall is required. SASSETA will supply and manage the firewall equipment and related LAN equipment.
- Technical support and active network management, such as traffic usage statistics, network status and performance visibility, etc.
- Scalability as business requirements change and develop.
- Support for VoIP telephony, video, data replication services and remote access.

2.4 REQUIRED DELIVERABLES

- **2.4.1** The service provider is expected to provide the following:
 - Design, supply, installation, configuration, commissioning and maintenance of a logically and administratively single, resilient, scalable Internet Connectivity and Voice (Telecommunication) Service at its office in Midrand, Johannesburg and 3 (three) regional offices in KwaZulu Natal (Durban, Pietermaritzburg, and Newcastle), with the potential growth of SASSETA into other provinces.
 - Provide internet uplink (300MB) between SASSETA and the internet service provider through a dedicated bandwidth which does not share bandwidth with the WAN links; 300MB divided as follows;
 - 200MB Head Office Midrand
 - 20MB PMB
 - 20MB DBN
 - 20MB NWC
 - 40MB spare for upcoming regions
 - Last mile connectivity into the building;
 - Telephone (VOICE service) through VOIP and the porting of the SASSETA telephone numbers;
 - Redundant (failover) internet connectivity and telephone services;
 - Ensure provided services are monitored 24/7/365 from operations centre that is manned by competent technical staff;
 - Enable SASSETA nominated staff access into a comprehensive monitoring (e.g. utilisation, status, quality, uptime and performance) dashboard that have clear indicators and all the probes that are being monitored;
 - Alert the SASSETA nominated staff of any warnings, faults and alarms via SMS, e-mail, etc.;

- Monthly reports must be provided to SASSETA's ICT staff. The reports must include as a minimum: uptime; utilisation; and performance against Service Level Targets;
- A service manager and account manager must be allocated to SASSETA to handle all service related queries and escalations; and
- Transfer and management of all DNS records for SASSETA owned domains from the current service provider(s).
- **2.4.2** The Bidder is expected to plan and conduct the installation of the project with minimal impact to daily operations and staff.

2.5 DURATION OF SERVICE

2.5.1 The contract period shall be from the date of appointment until 31st March 2023 subject to the performance of the service provider and operational requirements of SASSETA.

2.6 SKILLS AND EXPERIENCE OF THE BIDDING COMPANY AND THE TEAM MEMBERS PROPOSED FOR THE ASSIGNMENT

- **2.6.1** The bidding company should demonstrate the following skills and experience:
 - A minimum of three (3) assignments with public institutions or private institutions.
 - A minimum of three (3) signed reference letters from clients (existing or previous) must be attached. Reference letters must be on the client's letterhead, signed and clearly detailing the scope of work, duration and impression the client has with the service provider.

- 2.6.2 The team should demonstrate the experience in skills in the following
 - Bidders must submit CV's of three (3) technical members each with the listing their qualifications in ICT, or Networking or Telecommunication or similar discipline
 - Bidders must submit CV's of three (3) technical members, each with at least three years' experience in telecommunications implementation
 - The bidder should indicate which of the team members will be responsible for which components of work if more than one team member is proposed

2.7 PRICING REQUIREMENTS

2.7.1 Service Providers are requested to provide an all-inclusive cost of this project assignment.

2.8 ACCOUNTABILITY AND REPORTING

2.8.1 The service provider will report directly to the ICT Manager for the duration of the assignment.

2.9 INTELLECTUAL PROPERTY

2.9.1 The service provider will be contracting with SASSETA. All products and data of this project, in whatever format raw or analysed, will be the confidential information for utilisation by SASSETA. All information and documents, received from SASSETA or stakeholders, is to be kept confidential and may not be used or distributed in any format without the written approval of SASSETA. To this end, the service provider will be required to sign a confidentiality agreement within the Contract.

3 PROPOSED SELECTION CRITERIA

3.1 Compliance with minimum requirements

3.1.1 All bids duly lodged will be examined to determine compliance with bidding requirements and conditions. Bids with obvious deviations from the requirements/conditions, will be eliminated from further evaluation.

3.2 Conditions for selection/short listing

3.2.1 All submissions will be evaluated as follows:

3.2.1.1 Phase 1 – Requirements items

Service Providers must:

- Submit their proposal by the closing date and time. Proposals submitted after the closing date and time will be disqualified from further evaluation.
- Register their submission in the tender register at SASSETA reception.
 Proposals not recorded on the tender submission register at SASSETA reception will be disqualified from further evaluation.
- Complete and submit all Standard Bidding Documents (SBD) forms mentioned above on page 2 of this document, namely: SBD1, SBD3.3, SBD4, SBD 6.1, SBD 8 and SBD 9.

3.3 ADJUDICATION OF BID

3.1.1 The Bid Adjudication Committee will consider the recommendations of the Bid Evaluation Committee (BEC) and make a recommendation to the Award Authority to make the final award. The successful bidder will usually be the service provider scoring the highest number of points or it may be a lower scoring bid based on firm, verifiable and justifiable grounds or no award at all.
