### 1.5 LATE BIDS

- 1.5.1 Bids received late shall not be considered. A bid will be considered late if it arrived only one second after 11h00 or any time thereafter. Bids arriving late will not be considered under any circumstances. Bids received late shall be returned unopened to the bidder with the person delivering the documents. Bidders are therefore strongly advised to ensure that bids be despatched allowing enough time for any unforeseen events that may delay the delivery of the bid.
- 1.5.2 The official Telkom time (dial 1026) will be used to verify the exact closing time (11h00)

- 1.5.3 Bids sent to SASSETA via normal post or any other mechanism shall be deemed to be received at the date and time of arrival at the SASSETA premises (tender/bid box or reception). Bids received at the physical address after the closing date and time of the bid, shall therefore be deemed to be received late.

Bidder must at least:

Describe, in detail, exactly how they propose to carry out the activities to achieve the outcomes identified in the terms of reference. Bidders are required to have the basic office equipment and the resource/s (which must include, laptop, 3G connection, landline, own office with the basic office equipment) will be located within the region where the work will be done. They should identify any possible problems that might hinder delivery and indicate how they will avoid, or overcome such problems.

**Part 11: Experience in this field**

It is essential the service provider displays:

- ❖ The Bidder must provide signed reference letters on company letterheads of previous clients where the Bidder provided similar services.

**Part 12: Bidders National Treasury CSD registration report**

Bidders to submit their CSD report indicating the validity of the bidder’s registration. Directors listed on SBD 4 to be the same as those listed on the CSD report.

**1.8 NEGOTIATION**

- 1.8.1 SASSETA has the right to enter into negotiation with a prospective service provider regarding any terms and conditions, including price(s), of a proposed contract.

- 1.8.2 SASSETA shall not be obliged to accept the lowest of any quotation, offer or bid.
- 1.8.3 SASSETA issues this bid invitation in good faith; however, it reserves the right to:
- ❖ Cancel or delay the selection process at any time, without explanation,
  - ❖ Not to select any of the respondents to this bid invitation, without explanation,
  - ❖ Exclude certain services, without explanation.
- 1.8.4 All bidders will be informed whether they have been successful or not. A contract will only be deemed to be concluded when reduced to writing in a contract form signed by the designated responsible person of both parties.

## **1.9 REASONS FOR REJECTION**

- 1.9.1 SASSETA shall reject a bid for the award of a contract if the recommended bidder has committed a proven corrupt or fraudulent act in competing for the particular contract.
- 1.9.2 SASSETA may disregard the bid of any bidder if that bidder, or any of its directors:
- 1.9.2.1 have abused the Supply Chain Management systems of SASSETA.
  - 1.9.2.2 have committed proven fraud or any other improper conduct in relation to such systems.
  - 1.9.2.3 have failed to perform on any previous contract and the proof exists.
- 1.9.3 Such actions shall be communicated to the National Treasury.

## **2. TERMS OF REFERENCE**

### **2.1 INTRODUCTION AND BACKGROUND**

SASSETA was established on 1 July 2005. It is one of the twenty-one Sector Education and Training Authorities (SETAs) established in terms of the Skills Development Act (Act 97 of 1998) as amended. SASSETA's licence has been renewed until 31<sup>st</sup> March 2030. SASSETA is classified as a schedule 3A Public Entity in terms of the Public Finance Management Act, (Act 1 of 1999, as amended). SASSETA reports to the Department of Higher Education and Training.

SASSETA utilises Information and Communication Technology as the platform to manage and provide access its systems and communicate with its stakeholders. These include the internet/data and telecommunication services (in a form of telephone services). Currently the above services are provided by Liquid Telecom SA.

### **2.2 PURPOSE**

The purpose of this RFP is to appoint a suitably qualified and licensed service provider (Telco and ISP) to provide the internet and telecommunication (telephone/voice) services to SASSETA for a period of 5 (five) years from the date of appointment.

### **2.3 DETAILED SCOPE OF WORK AND DELIVERABLES**

The ISP will provide full Transmission Control Protocol with Internet Protocol (TCP/IP) Internet Service Provision and telephone service for the SASSETA offices in Midrand. The service is expected to be highly accessible and reliable, with overall uptime of no less than 99%.

Internet (Data) and Telecommunication services to be provided on a subscription and per use basis.

The bidder shall provide the necessary hardware and other services required to setup the Internet connection and telephone service. It involves the following:

- A dedicated, leased line of a minimum bandwidth of 300 Mbps Internet breakout from bidder's network, complete with relevant backup. This connection will primarily be used for internet browsing, hosted VoIP
  - The only option acceptable at the Head Office is Fibre optic; except for connection in the provinces.
  - For redundant connection, the bidder should provide a separate connection to different international gateway than primary connection through fiber optic connection.
- No limitations on traffic/ports; bandwidth capacity should be ensured through direct IP connection; no mandatory proxy servers and firewalls.
- The provided bandwidth must be dedicated (CIR 1:1).
- Internet service should not have additional payment or limitation by (a) traffic amount or (b) time.
- Service reliability must be ensured. Overall uptime should not be less than 99%.
- Data confidentiality guarantee; Provider may not scan traffic (if this should be done for finding problems in the network a prior UNDP agreement must be obtained).
- All necessary hardware, cabling and software (if required for Internet service) should be provided and set up cost should be included in the offer.
- Redundant, dedicated point to point links to the Internet.



- No firewall is required. SASSETA will supply and manage the firewall equipment and related LAN equipment.
- Technical support and active network management, such as traffic usage statistics, network status and performance visibility, etc.
- Scalability as business requirements change and develop.
- Support for VoIP telephony, video, data replication services and remote access.

## 2.4 REQUIRED DELIVERABLES

The service provider is expected to provide the following:

- Design, supply, installation, configuration, commissioning and maintenance of a logically and administratively single, resilient, scalable Internet Connectivity and Voice (Telecommunication) Service at its office in Midrand, Johannesburg and 3 (three ) regional offices in KwaZulu Natal ( Durban, Pietermaritzburg, and Newcastle), with the potential growth of SASSETA into other provinces.
- Provide internet uplink (300MB) between SASSETA and the internet service provider through a dedicated bandwidth which does not share bandwidth with the WAN links; **300Mbps divided as follows;**
  - **200Mbps Head Office Midrand**
  - **20Mbps PMB**
  - **20Mbps DBN**
  - **20Mbps NWC**
  - **40Mbps spare for upcoming regions**
- Last mile connectivity into the building;
- Telephone (VOICE service) through VOIP and the porting of the SASSETA telephone numbers;
- Redundant (failover) internet connectivity and telephone services;
- Ensure provided services are monitored 24/7/365 from operations centre that is manned by competent technical staff;
- Enable SASSETA nominated staff access into a comprehensive monitoring (e.g. utilisation, status, quality, uptime and performance) dashboard that have clear indicators and all the probes that are being monitored;
- Alert the SASSETA nominated staff of any warnings, faults and alarms via SMS, e-mail, etc.;
- Monthly reports must be provided to SASSETA's ICT staff. The reports must include as a minimum: uptime; utilisation; and performance against Service Level Targets;
- A service manager and account manager must be allocated to SASSETA to handle all service related queries and escalations; and
- Transfer and management of all DNS records for SASSETA owned domains from the current service provider(s).

**NB.:** The Bidder is expected to plan and conduct the installation of the project with minimal impact to daily operations and staff.

## 2.6 SKILLS AND EXPERIENCE OF THE BIDDING COMPANY AND THE TEAM MEMBERS PROPOSED FOR THE ASSIGNMENT

## 2.7 TIMEFRAMES FOR DELIVERY OF THE WORK

The assignment is estimated to be completed within 1 month from date of appointment.

## 2.8 SUBMISSION REQUIREMENTS

The proposal of the bidder is required to consist of, and demonstrate, the following:

- Understanding and experience in the scope of work
- Methodology as to how the scope of work will be executed;
- Project plan as to when various activities will be scheduled and when the deliverables will be submitted; and
- Value add suggestions that will demonstrate the expertise and suitability of the bidder in executing this contract.
- Profile of the bidder;
- team structure, roles and responsibilities;
- Detailed CVs of all team members;
- Experience of the bidder and team related to the skills required and in similar projects successfully undertaken;
- Signed reference letters on an official letterhead from three contactable referees demonstrating skills and expertise to undertake the contract

## 2.9 OTHER REQUIREMENTS:

- The Service Levels outlined within the SLA, which refer to service provider commitment to resolve the Service Requests within the applicable response time unless stated otherwise, must be conducted.

- The SLA/Warranty must cover repair or replacement for fair wear and tear of devices or the repair or replacement of inherently faulty devices listed in the product schedule, as provided by the Bidder.
  - All equipment furnished, but not limited to: routers, switches, phone equipment, software, shall be warranted for a period of fifteen (15) months after final acceptance and shall include parts, labour and installation. Telecomm and network equipment warranty shall be by manufacturer.
  - All equipment furnished shall be new, unused and not refurbished.
  - Responsibility Matrix and Project Schedule - A master project schedule must be included, along with a work responsibility matrix, identifying the tasks the vendor will perform and the tasks SASSETA is expected to perform to successfully implement the new system.
  - A complete maintenance and warranty agreement must be included as part of the bidder's proposal to support SASSETA between 07:30 and 16:00, Monday through Friday. The proposed agreement must include a bidder technician providing on-site service to diagnose and provide solutions. Remote access service may be acceptable depending on SASSETA's stated urgency of repair and shall be determined by SASSETA. Replacement parts must be readily available for prompt replacement - it is not acceptable to not have service for a day while parts are "on order".
  - Response Time – SASSETA is guaranteed a vendor technician on-site response time of no more than one (1) hours for all major system problems where telephone service is lost and a maximum of 24 hours' response to other system problems. Failure to comply will result in monetary compensation to SASSETA. The triggers to start and stop the "clock", compensation amount, and time increment are to be negotiated. This compensation will be credited on the account.

## 2.10 PRICING

Service Providers are requested to provide an all-inclusive cost of this project assignment on SBD 3.3.

All information and documents, received from SASSETA or stakeholders, is to be kept confidential and may not be used or distributed in any format without the written approval of SASSETA. To this end, the service provider will be required to sign a confidentiality agreement within the Contract.

### 3 PROPOSED SELECTION CRITERIA

3.1.1 All bids duly lodged will be examined to determine compliance with bidding requirements and conditions. Bids with obvious deviations from the requirements/conditions, will be eliminated from further evaluation.
