**Documents submitted on time by bidders shall not be returned.**

### 1.5 LATE BIDS

- 1.5.1 Bids received late shall not be considered. A bid will be considered late if it arrived only one second after 11h00 or any time thereafter. Bids arriving late will not be considered under any circumstances. Bids received late shall be returned unopened to the bidder with the person delivering the documents. Bidders are therefore strongly advised to ensure that bids be despatched allowing enough time for any unforeseen events that may delay the delivery of the bid.

- 1.5.2 The official Telkom time (dial 1026) will be used to verify the exact closing time (11h00)
- 1.5.3 Bids sent to SASSETA via normal post or any other mechanism shall be deemed to be received at the date and time of arrival at the SASSETA premises (tender/bid box or reception). Bids received at the physical address after the closing date and time of the bid, shall therefore be deemed to be received late.

**The value of this bid is estimated not to exceed R50 000 000 (all applicable taxes included) and therefore the 80/20 system shall be applicable**

### **Part 3: Declaration of Interest (SBD 4)**

Each party to the bid must complete and submit the Declaration of Interest.

### **Part 4: Preference Points Claim Form in terms of the Preferential Procurement Regulations 2017 (SBD 6.1)**

Bidders must complete and submit the Preference Points Claim Form.

A trust, consortium or joint venture:

- ❖ will qualify for points for their B-BBEE status level as a legal entity, provided that the entity submits their B-BBEE status level certificate OR a Letter from a registered Accounting Officer/ Auditor OR a sworn affidavit in terms of the Amended B-BBEE Codes from Exempted Micro Enterprises (EMEs) of R10 000 000 annual turnover.

- ❖ will qualify for points for their B-BBEE status level as an unincorporated entity, provided that the entity submits their consolidated B-BBEE scorecard as if they were a group structure and that such a consolidated B-BBEE scorecard is prepared for every separate bid.

**Part 9: Technical approach**

Bidder must at least:

Describe, in detail, exactly how they propose to carry out the activities to achieve the outcomes identified in the terms of reference. Bidders are required to have the basic office equipment and the resource/s (which must include, laptop, 3G connection, landline, own office with the basic office equipment) will be located within the region where the work will be done. They should identify any possible problems that might hinder delivery and indicate how they will avoid, or overcome such problems.

Describe how the work will be managed. Provide an organisation chart clearly indicating:

- ❖ The lines of reporting and supervision within the bidder’s team.
- ❖ The lines of reporting between the bidder and SASSETA.

Provide a work plan of activities. In addition to providing details of the estimated number of workdays for each activity, bidders are to supply a detailed timetable that identifies when certain activities will be undertaken and over what period they will be spread. The timing of activities, the time needed to complete them, and the order in which they will be undertaken must be explained and justified.

Please note that part 9 should be no longer than 10 single-sided A4 pages in Arial 11 (font size).

**Part 10: Team Details**

The bidder must provide:

- ❖ A comprehensive curriculum vitae (relevant to this bid and limited to two pages). In particular, the CV must highlight the team member(s) experience and qualifications to carry out the work

NB: It is to be noted that team members proposed for this assignment cannot be replaced without prior approval by the SASSETA.

**Part 11: Experience in this field**

It is essential the service provider displays:

- ❖ Experience as set out in the terms of reference
- ❖ The Bidder must provide signed reference letters on company letterheads of previous clients where the Bidder provided similar services.

## **Part 12: Bidders National Treasury CSD registration report**

Bidders to submit their CSD report indicating the validity of the bidder's registration. Directors listed on SBD 4 to be the same as those listed on the CSD report.

### **1.8 NEGOTIATION**

- 1.8.1 SASSETA has the right to enter into negotiation with a prospective service provider regarding any terms and conditions, including price(s), of a proposed contract.
- 1.8.2 SASSETA shall not be obliged to accept the lowest of any quotation, offer or bid.
- 1.8.3 SASSETA issues this bid invitation in good faith; however, it reserves the right to:
  - ❖ Cancel or delay the selection process at any time, without explanation,
  - ❖ Not to select any of the respondents to this bid invitation, without explanation,
  - ❖ Exclude certain services, without explanation.
- 1.8.4 All bidders will be informed whether they have been successful or not. A contract will only be deemed to be concluded when reduced to writing in a contract form signed by the designated responsible person of both parties.

### **1.9 REASONS FOR REJECTION**

- 1.9.1 SASSETA shall reject a bid for the award of a contract if the recommended bidder has committed a proven corrupt or fraudulent act in competing for the particular contract.
- 1.9.2 SASSETA may disregard the bid of any bidder if that bidder, or any of its directors:
  - 1.9.2.1 have abused the Supply Chain Management systems of SASSETA.
  - 1.9.2.2 have committed proven fraud or any other improper conduct in relation to such systems.
  - 1.9.2.3 have failed to perform on any previous contract and the proof exists.
- 1.9.3 Such actions shall be communicated to the National Treasury.

## **2 TERMS OF REFERENCE**

### **2.1 INTRODUCTION AND BACKGROUND**

SASSETA was established on 1 July 2005. It is one of the twenty-one Sector Education and Training Authorities (SETAs) established in terms of the Skills Development Act (Act 97 of 1998) as amended. SASSETA's licence has been extended to 31<sup>st</sup> March 2030. SASSETA is classified as a schedule 3A Public Entity in terms of the Public Finance Management Act, (Act 1 of 1999, as amended). SASSETA reports to the Department of Higher Education and Training.

The skills development environment requires regular financial support to learners undergoing training in the form stipends that are paid based on the attendance of class and workplace. SETA stipends are usually paid via Training Providers and Employers, in arrears, on the submission of manual attendance registers or claims. The payments to learners via direct deposit into the learner's bank accounts.

SASSETA is in the process of changing the system of administration and disbursement of learner stipends by implementing a real time learner attendance monitoring system which yields accurate and prompt stipends reports for all training projects. It is SASSETA's further intention to operationalize the disbursement of Learner Stipends direct to beneficiaries in the most cost effective manner and eliminate incidences of incorrect, late or non-payment of stipends.

### **2.2 PURPOSE**

The purpose of this assignment is to appoint a panel of service providers to provide a disbursement and management solution to SASSETA for a period of 5 years.

SASSETA requires a panel of service providers to implement the national rollout of the learner attendance monitoring system, administration of attendance based payment calculation and disbursements on a monthly or other regular timeframe as stipulated with the requisite reporting and financial stewardship responsibility for an initial period of 60 months.

The panel of service providers are required to have their own existing attendance system that uniquely identifies individual learners. The system is required to centrally generate attendance and stipends reports. It is SASSETA's intention to pay stipends and other allowances to each learner into the learner's bank account.

### **2.3 SCOPE OF WORK**

In order to achieve the above-mentioned objectives, SASSETA seeks to appoint a panel of service providers – with the requisite procurement, administrative, technical knowledge and implementation capabilities – that will undertake the end to end monitoring system rollout, stipend calculation and disbursement administration:

- a) A national rollout and supply of mechanism that can be used to uniquely identify individual learners and record attendance;
- b) Monthly administration, disbursement and reconciliation of stipends to qualifying recipients;
- c) Monthly Reporting on learner/beneficiary attendance and disbursements; and
- d) Maintenance and support of the mechanism proposed.

**The SASSETA will not entertain or consider proposals for only a portion or exclusion of any of the above stated deliverables. Provision of specified hardware components and or biometric devices is the responsibility of the Bidder.**

## 2.4 TIMEFRAMES FOR DELIVERY OF THE WORK

The successful service providers on this panel are appointed for a period of five years renewable annually based on service provider performance, budgetary implications and SASSETA requirements.

Commencement of the roll-out of the solution must be within thirty (30) days from date of appointment.

Successful service providers will be required to enter into a Service Level Agreement (SLA) with SASSETA.

**NB.:** SASSETA is looking at leveraging cost by applying economies of scale on the number of learners to be allocated per category. Bidders to provide a cost for one (beneficiary) on all the categories mentioned above.

Travelling costs to be arranged by the service provider and will be reimbursed at cost by SASSETA. Rate per kilometre travelled will be reimbursed as per Department of Transport rates.

## **2.6 ACCOUNTABILITY AND REPORTING**

Progress reports should be provided to the Project Manager on a monthly basis, providing challenges experienced, recommendations and resolutions as well as steps taken to resolve the incidents.

## **2.7 INTELLECTUAL PROPERTY**

The service provider will be contracting with SASSETA. All products and data of this project, in whatever format raw or analysed, will be the confidential information for utilisation by SASSETA. All information and documents, received from SASSETA or stakeholders, is to be kept confidential and may not be used or distributed in any format without the written approval of SASSETA. To this end, the service provider will be required to sign a confidentiality agreement within the Contract.

### 3 PROPOSED SELECTION CRITERIA

#### 3.1. Compliance with minimum requirements

- 3.1.1 All bids duly lodged will be examined to determine compliance with bidding requirements and conditions. Bids with obvious deviations from the requirements/conditions, will be eliminated from further evaluation

#### 3.2. Conditions for selection/short listing

- 3.2.1 All submissions will be evaluated as follows:

##### 3.2.1.1 Phase 1 – Required items

###### Service Providers must:

- Submit their proposal by the closing date and time. **Proposals submitted after the closing date and time will be disqualified from further evaluation.**
- Register the proposals in the tender register at SASSETA reception. **Proposals not recorded on the tender submission register at SASSETA reception will be disqualified from further evaluation.**
- complete and submit all Standard Bidding Documents (SBD) forms mentioned above on page 2 of this document, namely: SBD1, SBD3.3, SBD4, SBD 6.1, SBD 8 and SBD 9
- Be registered on the National Treasury Central Supplier Database (CSD) by the closing date and time of this request for quotation. Bidders are to provide SASSETA with a copy of their CSD registration report downloaded from the National Treasury CSD Website.
- Initial each page of the General Condition of Contract (Annexure A) and submit with the proposal

##### 3.2.1.2 Phase 2 – Functionality evaluation

Bidders who meet the required items requirements above will be evaluated on functionality requirements as per the table below:

The functionality calculation will be done based on the defined criteria and average thereof. Functionality evaluation will be undertaken in three (3) phases:

- (i) Technical functionality evaluation – will be scored out of a 100 with a minimum functionality threshold of 75%. Bidders who do not meet the required technical functionality threshold will be disqualified from further evaluation.
- (ii) Presentation evaluation - will be scored out of a 100 on its own and bidders are required to obtain 100% in order for them to be shortlisted to due diligence phase. Bidders who do not meet the required presentation threshold will be disqualified from further evaluation.
- (iii) Due Diligence – will also be scored out of 100 on its own and bidders are required to obtain 100% in order for them to be shortlisted to due diligence phase. Bidders who do not meet the required presentation threshold will be disqualified from further evaluation.

**All three phases of functionality will be combined to make a score of 100.**

- The overall average score for technical functionality evaluation (phase 1) will be 30% of all the three (3) phases.
- The overall average score for presentation evaluation (phase 2) will be 30% of all the three (3) phases.
- The overall average score for due diligence evaluation (phase 3) will be 40% of all the three (3) phases.

At the end of the three (3) functionality evaluation phases, the minimum average score average will be 75%. **If a bidder fails to score a minimum of 75% out of 100% for all three (3) functionality phases, the bid will be disregarded from further consideration.**

#### **(I) Technical Functionality Evaluation**

All proposals will be evaluated on the criteria provided in the table below. The proposals of all service providers will be rated on a scale of 0 to 5:

- 0: Document/item not submitted
- 3: Satisfactory should be adequate for stated element
- 5: Exceptional mastery of the requirement should ensure extremely effective performance.
