1.5 LATE BIDS

- 1.5.1 Bids received late shall not be considered. A bid will be considered late if it arrived only one second after 11h00 or any time thereafter. Bids arriving late will not be considered under any circumstances. Bidders are therefore strongly advised to ensure that bids be sent allowing enough time for any unforeseen events that may delay the delivery of the bid.
- 1.5.2 The official Telkom time (dial 1026) will be used to verify the exact closing time (11h00)

The value of this bid is estimated <u>not to exceed</u> R50 000 000 (all applicable taxes included) and therefore the 80/20 system shall be applicable.

Where the contract requires the successful bidder to travel to a venue different from SASSETA, the following travel and disbursement processes will be undertaken:

- Claim travel mileage costs applicable to this contract as per the Department of Transport rates
- Book only economy-class flights
- Book Group A hire cars, otherwise Group B are to be used for Service Providers outside of Gauteng.
- Utilise cost-effective mode of transport such as Uber/Taxify/Gautrain or shuttle services when travelling to and from the airport
- Book only Bed and Breakfast, Hotels, or other equivalent accommodations up to a Rand value of R1 400/ three (3) Star per night per person (including dinner, breakfast and parking).

- All travel to be approved by SASSETA before being undertaken

1.8 NEGOTIATION

- 1.8.1 SASSETA has the right to enter into negotiation with a prospective service provider regarding any terms and conditions, including price(s), of a proposed contract.
- 1.8.2 SASSETA shall not be obliged to accept the lowest of any quotation, offer or bid.
- 1.8.3 SASSETA issues this bid invitation in good faith; however, it reserves the right to:
 - Cancel or delay the selection process at any time, without explanation,

- Not to select any of the respondents to this bid invitation, without explanation.
- Exclude certain services, without explanation.
- 1.8.4 A contract will only be deemed to be concluded when reduced to writing in a contract form signed by the designated responsible person of both parties.

1.9 REASONS FOR REJECTION

- 1.9.1 SASSETA shall reject a bid for the award of a contract if the recommended bidder has committed a proven corrupt or fraudulent act in competing for the particular contract.
- 1.9.2 SASSETA may disregard the bid of any bidder if that bidder, or any of its directors:
 - 1.9.2.1 have abused the Supply Chain Management systems of SASSETA.
 - 1.9.2.2 have committed proven fraud or any other improper conduct in relation to such systems.
 - 1.9.2.3 have failed to perform on any previous contract and the proof exists.
- 1.9.3 Such actions shall be communicated to the National Treasury.

2. TERMS OF REFERENCE

2.1. INTRODUCTION AND BACKGROUND

- 2.1.1. SASSETA was established on 1 July 2005. It is one of the twenty-one Sector Education and Training Authorities (SETAs) established in terms of the Skills Development Act (Act 97 of 1998) as amended. SASSETA's licence has been renewed until 31st March 2030. SASSETA is classified as a schedule 3A Public Entity in terms of the Public Finance Management Act, (Act 1 of 1999, as amended). SASSETA reports to the Department of Higher Education and Training.
- 2.1.2. As per delegation of the Quality Council for Trades and Occupations (QCTO) in terms of the National Qualification Framework (NQF) Act (Act No.67 of 2008) and Skills Development Act, 1998 (Act No. 97 of 1998, as amended), the delegated functions of the QCTO entails that learner results facilitation of moderation among training providers should be effectively and efficiently evaluated.
- 2.1.3. External moderation (verification) requests are received from accredited training providers. Upon completion of training, then external moderation (verification) of learner results should be conducted by SASSETA Verifiers.

2.2. PURPOSE

2.2.1. SASSETA is looking at appointing a suitable and qualified pool/panel of External Verifiers nationally until 31st March 2028. Work will be rotated amongst the pool of verifiers depending on their availability.

2.3. SCOPE OF WORK

- 2.3.1. The successful service providers will be required to undertake the following:
 - 2.3.1.1. External moderation (verification) of learner results should be conducted by SASSETA External Verifiers.
 - 2.3.1.2. Conduct site validation visits to check whether the site exists (on an Adhoc basis).
 - 2.3.1.3. Conduct site visits to check whether the site is conducive for learning (on an Adhoc basis).
 - 2.3.1.4. Conduct monitoring visits to promote QCTO requirements
 - 2.3.1.5. Review internal assessment and moderation by sampling candidates' work.
 - 2.3.1.6. Monitor processes and procedures to ensure Training Providers' decisions are in accordance with accreditation and assessment requirements.
 - 2.3.1.7. Provide information, advice and support Training Providers in order to share good Practices.
 - 2.3.1.8. Alert SASSETA of changes that might affect the accreditation status of Providers.
 - 2.3.1.9. Have the ability to assess Qualifications Learning outcomes, types of assessment methods, scrutinise for validity, reliability, authenticity, currency, and sufficiency (VACS).
 - 2.3.1.10. Ensure that compliance to accreditation and assessment requirements.
 - 2.3.1.11. Ensure that consistency in the learners' portfolio and identify training issues needing to be addressed within the Safety and Security Sector.

2.4. REQUIRED DELIVERABLES

- 2.4.1. External Verifiers are appointed to conduct external moderation/verification visits on various SASSETA qualifications and the following deliverables will be expected on this assignment:
 - 2.4.1.1. Conduct planned verification visits,
 - 2.4.1.2. compile report on findings and forward to ETQA Manager within 7 days.

2.5. SKILLS AND EXPERIENCE OF THE BIDDING COMPANY AND THE TEAM MEMBER(S) PROPOSED FOR THE ASSIGNMENT

- 2.5.1. The applicants should demonstrate the following skills and experience.
 - Bidding Company/ Team leader are to submit three (3) or more signed reference letters on previous/current client's letterhead with contact details confirming their satisfaction of the service received from either the Bidding Company/Team Leader on the completed assignments.
 - The proposed team leader to submit their CV demonstrating a minimum of three (3) years' experience in undertaking external moderation (verification) with any SETA/ ETQA/ Government training institute(s).

2.6. MANDATORY REQUIREMENTS/ DISQUALIFICATION CRITERIA

2.6.1. Proof of ETDP SETA Assessor and Moderator statement of results or OD ETD qualification to be attached. International qualifications must be verified by SAQA and a copy of the letter confirming the validity of the qualifications must be attached. Responses/bidding documents submitted without both Assessor and Moderator SoR from ETDP SETA or OD ETD qualification will be automatically disqualified. International qualifications not verified by SAQA will also be automatically disqualified.

2.7. TIMEFRAME FOR DELIVERY OF THE WORK

2.7.1. The duration of this contract for the appointment of a panel of external verifiers will be from the date of appointment to 31 March 2028.

2.8. PRICING

SASSETA offers a fixed hourly rate with inflationary adjustments as follows:

- 2.8.1. Year 1- from date of appointment until 31 March 2024 = R850 inclusive of VAT
- 2.8.2. Year 2- 01 April 2024 until 31 March 2025 = To escalate by CPI + 2%
- 2.8.3. Year 3-01 April 2025 until 31 March 2026= To escalate by CPI + 2%
- 2.8.4. Year 4- 01 April 2026 until 31 March 2027= To escalate by CPI + 2%
- 2.8.5. Year 5- 01 April 2027 until 31 March 2028= To escalate by CPI + 2%

NB.: Interested bidders are to confirm acceptance of this hourly rate on their proposal.

2.9. CONFLICT OF INTEREST

- 2.9.1. As per this Bid, SASSETA will be appointing a panel of external verifiers. There is also another bid where SASSETA will be appointing a Panel of Learning Programme Evaluators.
- 2.9.2. In order to alleviate the possibility of a conflict of interest, a company that is appointed to conduct external verification assignments will not be allowed to conduct Learning Programme evaluation. In this regard, if a company bids for both assignments, they will only be appointed on one assignment.

2.10. ACCOUNTABILITY AND REPORTING

2.10.1. The external verifiers will report directly to ETQA Manager and submit reports to SASSETA within seven (7) days of completion of work.

2.11. INTELLECTUAL PROPERTY

2.11.1. The service provider will be contracting with SASSETA. All products and data of this project, in whatever format raw or analysed, will be confidential information for utilisation by SASSETA. All information and documents, received from SASSETA or stakeholders, is to be kept confidential and may not be used or distributed in any format without the written approval of SASSETA. To this end, the service provider will be required to sign a confidentiality agreement within the contract.

2.12. PROTECTION OF PERSONAL INFORMATION ACT

- 2.12.1. All Service Providers are to take note of the implications of POPIA act and any other data privacy Act applicable that SASSETA complies to. In compliance to the act, please be advised that the following are applicable to the treatment of vendor information:
- 2.12.2. All requested bid information will be solemnly utilized for the purpose of the bid evaluation processes. The vendor hereby consents the information provided as part of this bid will be utilized for supply chain processes of SASSETA and may be subject to multiple processing to enable the evaluation of this bid.
- 2.12.3. The vendor consents that the information collected will be retained for the duration of the evaluation and archived for records management purposes. The information will be disposed as per the SASSETA records management policies as prescribed by the national archives act. Furthermore, the information owner acknowledges that the information provided will be scanned into digital records which are retained on the SASSETA backup servers and that are replicated to backup media. SASSETA does confirm that the organization adopts industry best practice with regards to the safeguarding of digital records whether locally stored or retained in backup media.
- 2.12.4. SASSETA confirms that all submitted records will be retained in their original form and will not be altered with to preserve the quality and originality of information provided.
- 2.12.5. SASSETA confirms that the Information Officer is duly responsible for vendor information provided and exercises stringent measures to ensure that information is secured and solemnly utilized for the purpose of use. No vendor records will be distributed or utilized for any processes outside the current bid that the information has been requested for.

3. PROPOSED SELECTION CRITERIA

3.1 Compliance requirements

3.1.1 All bids duly lodged will be examined to determine compliance with bidding requirements and conditions. Bids with obvious deviations from the requirements/conditions, will be eliminated from further evaluation.

3.2 Conditions for selection/short listing

3.2.1 All submissions will be evaluated as follows:

3.2.1.1 Phase 1 - Required items, Service Providers to:

- Submit their responses/bidding documents by the closing date and time. Responses/bidding documents submitted after the date and time will be disqualified from further evaluation.
- Register the responses/bidding documents in the tender register at the SASSETA reception. Responses/bidding documents not recorded on the tender submission register at the SASSETA reception will be disqualified from further evaluation.
- Proof of ETDP SETA Assessor and Moderator statement of results or OD ETD qualification to be attached.Responses/bidding documents submitted without both Assessor and Moderator SoR from ETDP SETA or OD ETD qualification will be automatically disqualified. International qualifications not verified by SAQA will also be automatically disqualified.
